I am writing in hopes that our East Lake Community will receive immediate help in increasing their staff to answer calls for Medical Emergencies.

I am a local resident in The Meadows and today I was a witness to a very slow response for an elderly man who had fallen in our street. Being a mom of two children, I stood frantic waiting along-side his wife for a rescue team to arrive. Horrible thoughts went through my mind and the waiting was so frightening.

- What if this person had a head injury?
- Where are the paramedics?
- What if he is bleeding internally?
- My children were so scared that help was not anywhere in site.
- What if this was one of my children?

Lying in the street helpless for over 16 minutes is way too long and if bleeding out/internally would probably have not survived.

Thank God for the local fire department. Those men were here in a flash and doing everything they could until the medical units showed up.

I truly hope that this issue is addressed sooner rather than later, as lives depend on these teams!
