- b. Commissioner Kenney discussed the fact that there were both Commissioner By-Laws and an SOG that govern the Commissioners behavior. He said he will be looking into collapsing the two documents down into to one governing document that will cover everything needed, working with legal and internal parties as needed in this process.
- c. Commissioner Dalrymple read the following statement, which he had also previously emailed to Staff and Commissioners, into the Minutes as a personal statement: "While it is the practice of ELFR to wear masks while on duty, the department has no authority over what the employees and commissioners do on their own time. Everyone has a right to make their own decisions. After all the evidence was examined in my arrest in Key West, it was determined there was not enough evidence and the case was thrown out. As stated in the last commission meeting this is still the United States and we are presumed innocent until proven guilty." Chairman Kenney stated as a point of order that he was not sure about breadth and length of the Department's ability tell the Firefighters and members of the force what they cannot do while off duty so he did not think there should be such a blanket statement made that they cannot tell the Firefighters what to do off duty.
